

THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF LIMERICK

BY-Law No. 2011-15

A By-Law to convey the redundant portions of Pleasure Bay Road to the adjoining owner and to receive a conveyance of the necessary portions of the property for the current location of Pleasure Bay Road from the adjoining owner.


The Council of the Township of Limerick enacts as follows:

1. That all that property of the said Pleasure Bay Road designated as Part Lots 2 and 3 of Concession 4, as described as Parts 1,3,5,7 and 9 on Plan 21R-23509, and Part Lot 3 of Concession 5 as in Parts 3,5,and 6 on Plan 21R-23510 be and the same are hereby declared to be redundant;
2. That upon and after the passing of this By-Law all that part of the said Pleasure Bay Road designated Parts Lots 2 and 3 of Concession 4, as described as parts 1,3,5,7 and 9 on Plan 21R-23509, and Part Lot 3 of Concession 5 as in Parts 3, 5 and 6 on Plan 21R-23510 be and the same is hereby closed and stopped up;
3. That the part of the said redundant portion of Pleasure Bay Road designated as Part Lots 2 and 3 of Concession 4, as described as Parts 1,3,5,7 and 9 on Plan 21R-23509, and Part Lot 3 of Concession 5 as in Parts 3,5 and 6 on Plan 21R-23510 shall be transferred to J.M. Longyear Canada, ULC;
4. The Reeve and the Clerk of the Municipality of the Township of Limerick are hereby authorized to sign or execute such Deeds or other Documents as may be necessary to effect the closure and conveyance of that part of the said redundant portion of Pleasure Bay Road designated as Part Lots 2 and 3 of Concession 4, as described as Parts 1,3,5,7 and 9 on Plan 21R-23509, and Part Lot 3 of Concession 5 as in Parts 3,5,and 6 on Plan 21R-23510;
5. The Reeve and Clerk are hereby further authorized to sign or execute such Deeds or other documents as may be necessary to effect the transfer from J.M. Longyear Canada, ULC to the Township of Limerick being Part Lots 2 and 3 of Concession 4, as in Part 10 through to 18 inclusive on Plan 21R-23509, Part of Lot 2 of Concession 3, as in Part 1 on Plan 21R-23508, Part of Lot 3 on Concession 5, as in Parts 8 and 9 on Plan 21R-23510, Part of Lot 3 on Concession 5 as in Parts 10 and 11, on Plan 21R-23510, and Part of Lot 4 on Concession 5 as in Part 1, on Plan 21R-23510;
6. In accordance with section 34 of the *Municipal Act, 2001*, this By-Law shall not take effect until a certified copy has been registered in the proper land registry office.
7. This By-Law shall into effect upon its third reading.
