BY-LAW NUMBER 2013-14

Being a by-law to stop up and to sell that part of the Original shore road allowance along Steenburg (Bass) Lake In Front of Lot 29, Concession 2, Township of Limerick, County of Hastings, designated as Part 1 on Plan 21R-24006


The Council of the Township of Limerick enacts as follows:


1. That all that part of the said shore road allowance designated as Part 1 on Plan 21R-24006, be and the same is hereby declared to be surplus;
2. That upon and after the passing of this By-law all that part of the said shore road allowance designated Part 1 on Plan 21R-24006 be and the same is hereby permanently closed and stopped up;
3. That all that part of the said shore road allowance designated as designated as Part 1 on Plan 21R-24006 shall be sold to the adjoining owner or owners or such other persons as may be approved by Council of the Township of Limerick for the purchase price of \$250.00 for 92.4 feet of frontage;
4. The Reeve and Clerk of the Municipality of the Township of Limerick are hereby authorized to sign or execute such Deeds or other documents as may be necessary to effect closure and conveyance of that part of the said unopened shore road allowance designated as such parts being shown as Part 1 on Plan 21R-24006.
5. In accordance with Section 34 of the *Municipal Act, 2001*, this By-law shall not take effect until a certified copy has been registered in the proper land registry office.
6. This By-law shall come into effect upon its third reading.

READ a First time this 13th day of August 2013.

READ a Second time this 13th day of August 2013.

READ a Third Time and finally passed this 13th day of August 2013.


STATUTORY DECLARATION

1. I am the duly appointed Clerk-Treasurer of the Corporation of the Township of Limerick (herein called the "Township") and as such have full knowledge of the matters hereinafter set out, except where stated to be based on information and belief.
2. Now produced and shown to me and marked as Exhibit "A" to this my affidavit is a true copy of a notice of the proposed closed and sale of the said Shore Allowance which was posted on the Municipal website at least 10 days prior to the passage of the Bylaw. The Notice was also posted at the township office and at the local General Store located at 22014 Highway 62 as of July 30th, 2013.
3. At a properly constituted meeting of council held on August 13th, 2011, the date upon which the notice hereinbefore referred to stated that the by-law would be considered, the council of the Township considered the proposed stopping up, closure and sale of the Shore Allowance. At the meeting no one appeared in person or by counsel to make representations with respect to the proposed closing of the Shore Allowance. Council of the Township proceeded to pass By-law 2013-14.
4. To the best of my knowledge and belief, no person has be reason of the passage of the said By-law been deprived of the means of ingress or egress to or from his or her property.
